

**2020 TACO BELL SURVEY SWEEPSTAKES**  
**OFFICIAL RULES**

**NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

1. **SPONSOR:** This 2020 Taco Bell Survey Sweepstakes (“Sweepstakes”) is sponsored by Taco Bell Corp., 1 Glen Bell Way, Irvine, CA 92618 (“Sponsor”).
2. **WHO IS ELIGIBLE:** This Sweepstakes is open to individual legal residents of the 50 United States and the District of Columbia who are age 18 or older at time of entry. Employees and their immediate family members and those living in the same household of Sponsor, independent administrator (“Administrator”), Yum! Brands, Inc., Taco Bell participating restaurants, and each of their respective affiliates, subsidiaries, advertising, promotion and internet agencies (collectively “Released Parties”) are not eligible. Void where prohibited or restricted by law.
3. **ENTRY PERIODS:** The Sweepstakes begins at 12:00 AM Central Time (“CT”) on January 1, 2020 and ends at 11:59:59 PM CT on December 29, 2020 (“Sweepstakes Period”). The Sweepstakes Period consists of the following thirteen (13) entry periods (each an “Entry Period”):

Non-winning entries **will not** carry forward into subsequent Entry Periods. Sponsor’s computer is the official time-keeping device for the Sweepstakes.

4. **HOW TO ENTER:** Enter the Sweepstakes:
  - A. **ONLINE:** When you purchase any food or beverage item at a participating Taco Bell restaurant in the 50 United States and the District of Columbia during the Sweepstakes Period, enter the unique code (“Code”) on your cash register receipt at [www.tellthebell.com](http://www.tellthebell.com) and follow the on-screen instructions to complete a survey. After you complete the survey, you will receive one (1) entry into the applicable Entry Period.

**B. ALTERNATE METHOD OF ENTRY:** To enter without a purchase, an eligible entrant may visit <https://alternatemethodofentry.com/013300> and complete and submit the registration form. Then follow the links and instructions to save the registration form as a PDF with the barcode present. Then email the PDF to [AlternateEntry@prizelogic.com](mailto:AlternateEntry@prizelogic.com) by the respective Entry Period end date.

**Entry Limit:** Regardless of the method of entry, limit one (1) entry per person per Entry Period. If more than one (1) entry is received from the same person/email address in the same Entry Period, the additional entries will be invalid.

- 5. RANDOM DRAWINGS:** On or about each Drawing Date listed in Section 1, the Administrator will randomly select four (4) potential prize winners from all eligible entries received in the applicable Entry Period. Each winner is considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules.
- 6. WINNER NOTIFICATION:** Winners will be notified within approximately one (1) week of each Drawing Date. Administrator will contact winners by telephone to request a mailing address for prize fulfillment. Administrator will leave one (1) voice message with instructions. If voice messaging is not available or if potential winner does not respond within three (3) business days, he/she forfeits the prize. A winner may be disqualified if his or her prize, winner notification or other communication is returned as undeliverable or if winner fails to respond within the timeframe specified in the winner notification. Prizes will be mailed to winners at the addresses provided during winner verification/mail-in entry approximately six (6) to eight (8) weeks after verification.
- 7. PRIZES:** Fifty-two (52) Prizes (4 Prizes per Entry Period): each, a \$500 check made payable to the winner. **PRIZE LIMIT:** one (1) prize per household.   - B. BY PARTICIPATING IN THIS SWEEPSTAKES: EACH ENTRANT REPRESENTS TO SPONSOR THAT HE OR SHE HAS THE LEGAL CAPACITY TO AGREE TO THE TERMS OF THESE OFFICIAL RULES AND HAS COMPLIED WITH THEM. EACH ENTRANT ALSO AGREES TO RELEASE THE RELEASED PARTIES FROM ANY AND**

**ALL LIABILITY, LOSSES OR DAMAGES ARISING FROM OR IN CONNECTION WITH THE SWEEPSTAKES OR THE AWARDING, RECEIPT AND/OR USE OR MISUSE OF A PRIZE OR PARTICIPATION IN ANY PRIZE-RELATED ACTIVITY.**

- 9. LIMITATION OF LIABILITY:** By participating in this Sweepstakes, entrants agree that the Released Parties are not responsible for: (i) lost, late, incomplete, stolen, misdirected, postage due or undeliverable e-mail/text notifications or postal mail; (ii) any computer, telephone, satellite, cable, network, electronic or Internet hardware or software malfunctions, failures, connections, or availability; (iii) garbled, corrupt or jumbled transmissions, service provider/network accessibility, availability or traffic congestion; (iv) any technical, mechanical, printing or typographical or other error; (v) the incorrect or inaccurate capture of registration information or the failure to capture, or loss of, any such information; (vi) any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, technical error, theft or destruction or unauthorized access to the Sweepstakes; (vii) any injury or damage, whether personal or property, to entrants or to any person's computer related to or resulting from participating in the Sweepstakes and/or accepting a prize; and (viii) entries that are late, forged, lost, misplaced, misdirected, tampered with, incomplete, deleted, damaged, garbled or otherwise not in compliance with the Official Rules. IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION ADMINISTERED BY THE AMERICAN ARBITRATION ASSOCIATION IN ACCORDANCE WITH ITS ARBITRATION RULES AND PROCEDURES OR SUBSEQUENT VERSIONS THEREOF ("AAA RULES"). THE AAA RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN MICHIGAN. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN OAKLAND COUNTY, MICHIGAN. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. ENTRANTS AGREE THAT THE RIGHTS AND OBLIGATIONS OF ANY ENTRANT AND/OR SWEEPSTAKES ENTITIES AND/OR ANY OTHER PARTY SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION.
